BYLAW NUMBER 1173-P-26

A BYLAW OF THE TOWN OF UNITY TO SET THE ENVIRONMENT LEVY FEES AND THE CATEGORIES FOR USE OF RECYCLING BINS.

The Council of the Town of Unity ('Town'), in the Province of Saskatchewan enacts as follows:

1. This Bylaw may be cited as the Environmental Levy Bylaw.
2. Definitions:

"Billing Period" shall be monthly, starting January 1, 2026

The Town shall invoice the residents within five (5) days from the end of the billing period.

3. **Category - Residential**

4. **Category M-EL -Businesses using a 96 gallon bin with bi-weekly pick up:**

• Jan 01, 2026 – Dec 31, 2026	<u>Monthly</u> \$ 13.00

5. **Category M-EL2 -Businesses using a 4 yard bin with bi-weekly pick up:**

• Jan 01, 2026 – Dec 31, 2026	<u>Monthly</u> \$ 125.00

6. **Category M-EL3 -Businesses using a 6 yard bin with bi-weekly pick up:**

• Jan 01, 2026 – Dec 31, 2026	<u>Monthly</u> \$ 150.00

7. **Category M-EL4 -Businesses using a 6 yard bin with weekly pick up:**

• Jan 01, 2026 – Dec 31, 2026	<u>Monthly</u> \$ 275.00

8. **Category M-EL6 -Businesses using a 4 yard bin with monthly pick up:**

• **Jan 01, 2026 – Dec 31, 2026** Monthly
\$ 95.00

9. **Category M-EL7 -Businesses using a 4 yard bin with weekly pick up:**

• **Jan 01, 2026 – Dec 31, 2026** Monthly
\$ 225.00

10. **Category M-EL8 -Businesses using a 6 yard bin with monthly pick up:**

• **Jan 01, 2026 – Dec 31, 2026** Monthly
\$ 125.00

11. A minimum fee, as follows, will apply to any residents and businesses who do not utilize the recycling program with the Town but have their own private recycling arrangement:

• **Jan 01, 2026 – Dec 31, 2026** Monthly
\$ 13.00

12. Bylaw **1153-P-24** is hereby repealed.

13. This bylaw shall have full force and effect on **January 1, 2026**.
